General Service Board and GSO Updates

The recommendation to hold two Forums this year – the East and West U.S./Canada Forums respectively – was approved by the Board. To that end, planning for the December 5 East US/Canada and December 19 West US/Canada Forums are moving along. The one-day forums will include sharing by Delegates from the respective regions who have been invited to moderate themed workshops of their choice; a panel discussion with local Central Offices/Intergroups; an A.A. History tour with Sister Judith and Michelle Mirza; sharing by our Class A's (a segment titled "A Class Act"); "A.A. Around the World with our trustees' at large; past trustee sharing; a screening room, and much more! GSO is putting the finishing touches on the Registration form.

Please welcome our incoming CFO, Paul Konigstein, who joined our General Service Office on Monday, October 5. Paul, a non-alcoholic, comes to GSO with many years as a leader with non-profit finance experience. We all look forward to the benefit that this experience will bring to GSO.

Financial Update

The General Service Board has authorized a drawdown of \$1.5 million from the Reserve Fund by A.A. World Services, Inc. to cover cash flow requirements in the 4th quarter of 2020. This will put the Reserve Fund balance at approximately \$13.1 million, which reflects a level of approximately 7.8 months of office operating expenses. (The Reserve Fund calculation is based on recent actual operating expenses.) The full letter announcing this draw down from our GSO General Manager is attached to electronic version of this report. Much of the 4th quarter cash flow challenges were due to the VRIP payouts.

We also received a communication from our GSB that contained the Compiled Q & A from the "Special Virtual Finance Presentation to 70th G.S.C." on August 15, 2020. I have attached the document for your review. There were answers to a total of 49 questions that were forwarded to the members of the GSC. Seven questions were removed, because the answers are still "pending". These are:

- 2020 International Convention potential loss amount (Q17)
- Add salaries into 70th GSC expense recap (Q26)
- Request for information on drawdown and cashflow (Q48)
- Full ERP report including a project summary narrative since inception (Q7, Q11., Q11.5 & Q27)

If you have any questions after reviewing the document, please feel free to reach out.

We need to once again acknowledge and send a message of gratitude to all of you because the outreach to the membership for 7th Tradition support resulted in Sept. 2020 contributions that were once again in excess of \$800K. Total contributions from all sources year to date are over \$7 million.
